Presentation title: 'High Seas Treaties'

Dr Tom Appleby, Associate Professor in Property Law, University of the West of England



Dr Thomas Appleby is a former commercial lawyer and was a trustee of a commercial port. He is an Associate Professor at the University of the West of England in Bristol specialising in the allocation of marine rights. He leads the MSc in Real Estate Management at UWE. He has been involved in several landmark legal actions concerning the management of proprietary rights and the sea, he has appeared before various Parliamentary Select Committees and has spoken in the European Parliament. He is also a trustee of leading UK marine charity, the Blue Marine Foundation. He is currently engaged in work

associated with the UN treaty negotiations safeguarding biodiversity beyond national jurisdiction.

Presentation Title: 'Land valuation & effective transfer/acquisition – essential for emerging and informal markets'.

James Kavanagh MRICS C.Geog is a Chartered Land Surveyor & Chartered Geographer & Director of Global Land & Resources with The Royal Institution of Chartered Surveyors (RICS) www.rics.org/land jkavanagh@rics.org



This presentation will look at how informal markets in land & property operate (RICS research) and explore how the attribution of 'value' can be a powerful 'kickstart' to tenure security and the establishment of legitimate ownership rights. It will also look at global 'soft' law initiatives such as the UNFAO land tenure value guide and GLTN unregistered land value guidelines and how international standards such as LADM & due diligence standards such as ILMS seek to implement policy into practice and can help streamline the transfer process.

Presentation Title: 'Developing the United Nations Integrated Geospatial Information Framework' Christin Walter, Strategy Advisor, Ordnance Survey



Christin Walter is a geospatial professional at Ordnance Survey with experience in strategy and (international) policy.

She is the author of *The Smart City Strategic Growth Map* – a guide for local government decision makers – published as part of the <u>European Commission Horizon 2020 ESPRESSO</u> <u>project</u> which examines the cross-city capabilities that enable a city to become smarter, and explores how standards benefit the city development process. Currently, Christin is leading on the third revision of the United Nations Committee of Experts on Global Geospatial Information Management (UN-GGIM) report *Future Trends in Geospatial Information Management: The Five to Ten Year Vision*. The report will explore the impact of the trends on the UN Integrated `Geospatial Information Framework.

Presentation Title: 'Better access to geospatial data to support housing development' Hugh Phillips - Cabinet Office, UK Government



Hugh is the Data and Standards Lead at the Geospatial Commission and as such he works primarily with the 6 Partner Bodies (OS, UKHO, BGS, HMLR, CA and VOA) to find ways to improve the discoverability, accessibility and interoperability of their data. He also sits on the DFTG and the DCMS data quality experts group. He is seconded in from the UK Hydrographic Office where he has worked in a wide range of technical and management roles over 30 years, including satellite remote sensing, international standards development, software development, product management and programme management.
